# Friends of the Meadows and Bruntsfield Links Summary of 2020 AGM minutes (meeting by Zoom)

The meeting was chaired by the convener, Jim Orr, and there were fifteen members present. The usual business was conducted, Minutes of Previous Meeting approved, existing trustees re-elected, including two new trustees, and the Financial Report approved.

In the Annual Report, Bridget Stevens asked about the memorial bench for Robin Morris and Neil Roger confirmed that it is in place on Bruntsfield Links. The plaque will be funded by Merchiston Community Council.

In Any Other Business, Graeme Cruickshank asked for an update about the Jawbones and Neil Roger reported that they have been restored and will be reinstated in the Spring 2021. Jimmy Robertson mentioned that the Short Hole Golf Course has been closed for the first summer since the end of the War; the flags are considered a health risk, and the course is vulnerable to picnickers and BBQs.

The photograph shows a fine young **ROWAN** (*Sorbus aucuparia*) at South Links by Muriel Spark Walk.


The purchase and planting was organised by FoMBL (Friends of the Meadows and Bruntsfield Links) in honour of Heather Goodare (past convener).

#### **Cricket Pavilion**

The pavilion has been unused for some time, because of the Pandemic restrictions. Unfortunately the current tenant may have to leave, so this means that we do not know yet if she will be able to renew her lease, or if it will be taken over by another tenant. However, it certainly needs a lot of work to bring it up to standard which will involve a great deal of expenditure, and of course there is the problem of the toilet provision.

The important thing is that the building is put back into use fairly quickly and not allowed to deteriorate any further. The Pavilion is an iconic building, and forms a key part of the character of the Meadows, which in turn forms a key component of the Marchmont, Meadows & Morningside Conservation Area. We will be in contact with the Council representative, and also other conservation agencies, so we will hope to have positive news about its future soon.

Other volunteers just collected litter - a lot of it around benches. Other volunteers said there was a lot of broken glass in the big children's playpark near Summerhall. They did their best but it needs more attention there.

Finally over the last three FoMBL sessions we have tried to sort out the banana-shaped green strip running along one side of Marchmont Crescent. We have cleared an astounding amount of stuff (litter and large dumped stuff). This strip actually needs a team to sort out the overgrown vegetation and remove all the broken large branches as well as a number of pots that have been lying there neglected since possibly 2017 when someone who used to take care of it died. We do make a difference. We do enjoy our sessions too.

# **Edinburgh Biodiversity Partnership**

Edinburgh City Council have produced a document about biodiversity in parks and green spaces. Here is a short extract, with contact details at the end. I am sorry, the whole document is not available online.

#### 'Introduction

Parks and greenspaces have many functions. They provide amenity, recreation and places to play. They benefit our physical and mental wellbeing. They generate clean air and can store greenhouse gasses. Many of us go to parks to experience nature. Parks can also benefit biodiversity by providing places for plants and animals to live, feed and reproduce.

The purpose of this guide is to help park managers and others look at the features that make up their parks and make them better for biodiversity. For each park feature there is a 'pick list' of options that may benefit biodiversity. These biodiversity options can easily be added to management plans and carried out on the ground.

The guide aims to put as much knowledge as possible in the hands of the park managers. But not all options are suitable for all parks. For example it may be impossible to create a new pond and wetland in your park, or you may have good reasons not to plant any more trees. This is a guide, not a set of instructions!

The guide has the following sections:

<u>Section 2</u> lists some general principles for the benefit of biodiversity which can be applied to all parks and greenspaces.

<u>Section 3</u> looks at typical park features and gives you a pick list of options to improve them for biodiversity.

<u>Section</u> 4 looks at creating new habitats or features for priority habitats and species.

The <u>appendices</u> are lists of useful native and non-native plants that will benefit biodiversity. There is also a list of further reading.'
