Core funds. This is "unrestricted" money (from subscriptions, donations, etc) which we can use for anything we like. If we underspend by a small amount then our funders are unlikely to ask for the reminder back. Our finances are very healthy with £2,201 core funds carried forward.

Greening Our Street. The last £77.50 was paid back to them in 2018. *Easiest just to ignore these balances*.

Underbelly Fund. There are no restrictions on the Underbelly money and we use it for projects. Planned and ongoing projects not included in the 2018/19 accounts are as follows

- 1 Nelson's Pillars sign £900 plus £350 for ground work and so total estimated = £1,250
- 2 Royal Infirmary sign £300 to be added to the £998. The Council will fund ground works.
- 3 Mason's Pillars sign £1,100 plus £350 for ground works and so total = £1,450
- 4 Paint metal railings estimated to be £1,000
- 5 Contribution to further play equipment amount to be decided.

Total estimated contribution from core funds = £4,000
